



## RELEASE, WAIVER, INDEMNIFICATION, HOLD HARMLESS, AND ASSUMPTION OF THE RISK AGREEMENT

I, the undersigned, certify that I fully understand the nature of this course that I am voluntarily participating in, that it is dynamic, physically demanding, and intense and revolves around subjects and elements that can pose a serious risk to myself and/or other participating individuals.

I certify that I am at least 18 years of age or older, in appropriate physical, medical, and mental/emotional condition to participate in this type of course/training. I certify that I am aware of potential risks involved for myself and to other participants that may arise due to accidents and/or negligence. I certify that I am a law-abiding citizen of good moral character and intent, and possess no serious criminal record for which a pardon has not been granted, and that I do not belong to or associate with any known criminal or terrorist organizations.

I agree to indemnify, hold harmless, and defend Foo Dogs Defensive Tactics and any of its owners, instructors, employees, directors, officers, agents, or affiliates (hereinafter "FDDT"), from any and all fault, liabilities, costs, expenses, claims, demands, or lawsuits arising out of, related to, or connected with: the discharge of firearms or use of other various weapons and/or training tools; the course of instruction; my participation in the course of instruction; curriculum; future employment; the range, buildings, land, landowners, and premises used for the course of instruction (hereinafter the "Premises"); my presence on or use of said Premises; and any and all acts or omissions of my own. Should any such claim, demand, or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of the United States or of any State, or under any theory of law or equity, I will indemnify, hold harmless, and defend FDDT from any and all costs, expenses, or liability including but not limited to, the cost of any settlement or judgment made or rendered against FDDT, whether individually, jointly, or in so lido with myself, together with all costs of court and other costs or expenses incurred in connection with any claim, demand, or lawsuit, including attorney's fees.

I furthermore waive for myself and my executors, administrators, assignees, or heirs, any and all rights and claims for damages, losses, demands, and any other actions whatsoever, which I may have or which may arise against FDDT, (including but not limited to any and all injuries, damages, or illnesses suffered by me or by my property), which may, in any way whatsoever, arise out of, be related to, or be connected with: the course of instruction; the Premises, including any latent defect in the Premises; my presence on or use of said Premises; my property (whether or not entrusted to FDDT), and the discharge of firearms/use of other various weapons and/or training tools. FDDT shall not be liable for, and I, the undersigned, on behalf of himself/herself and his/her executors, administrators, assignees, or heirs, hereby expressly releases FDDT from any and all such claims.

This instrument binds the Undersigned and his/her executors, administrators, assignees, or heirs.
